**REGISTRATION FEE AND DEADLINE** to participate in benefits which accrue to eligible registered bands for MBOCHCI Carnival 2017 is **June 30, 2017**. Late registration may be accepted from July 1, 2017 but **NO** benefits shall accrue to any late band registrations.. Early registration fees shall be applied according to the following schedule: \$300 for bands that participated in the parade for the last two years; \$500 for bands that participated in the parade in **2016** only, and \$3,000 for newly-registered bands. Late registration fee is \$4,000.00. Registrations will be accepted after August 31, 2017 with further penalties, subject to approval by MBOCHCI. Checks or money orders should be made payable to "MIAMI-BROWARD ONE CARNIVAL HOST COMMITTEE INC." **NOTE: THERE SHALL BE NO REFUNDS ON REGISTRATION FEES. NO T-SHIRT, CAMOUFLAGE, PAINT OR MUD BANDS OR SECTIONS SHALL BE ALLOWED TO PARTICIPATE IN THE PARADE.** Please return check and SIGNED registration form to MBOCHCI at the above address.

The parties hereby represent and warrant that (a) it has the right and authority to enter into this agreement and (b) the execution and performance of this agreement will not violate or conflict with the provisions of any agreement by which it is bound. The Band, the Band Leader, its officers and directors and/or its affiliates, individually or otherwise, shall be prohibited from producing or assisting to produce another carnival in direct competition with the MBOCHCI carnival in Miami-Dade, Broward, Palm Beach or Monroe Counties or in violation of this agreement in **2017**. **Further, as a condition of registration, all registered bands must submit proof of commercial liability insurance, at a minimum of \$1,000,000 coverage, for their respective organization and/or company. In addition, each registered band in the parade must ensure that all registered participating masqueraders submit an executed Parade Participant Release in the form attached hereto.**

I hereby agree on behalf of myself and all members of my band, and the Designer and Producer of the above presentation, to adhere to and comply with all the rules (of which I am in possession and have read) as stipulated by MBOCHCI for 2017. I submit to the sanctions therein contained and agree that nothing shall limit the right of MBOCHCI to photograph, record, film, videotape and broadcast and to transmit via the Internet the performance of the said presentation at any event produced by MBOCHCI or to utilize them in the marketing and promotion of MBOCHCI. It is expressly agreed that MBOCHCI may employ or authorize any third party, including the media, to exercise these rights on its behalf. I acknowledge that I am aware of the benefits offered to registered bands **for 2017**.
